

Ely Place is a unique, attractive, historic, gated cul-de-sac similar in some respects to 10 Downing Street. It's situated directly to the north of Holborn Circus near Hatton Garden. Audrey House is the largest and most prominent building on Ely Place, situated adjacent to the historic St. Etheldreda's Church. The building has an ornate period façade and has been extensively redeveloped and modernized behind to provide a large, modern, professional office building with commissionaire, new receptions, lifts, WC's and showers.

The available part 4<sup>th</sup> floor was recently comprehensively refurbished and fitted as very attractive open plan offices with furniture, fully cabled, several meeting rooms, beautiful kitchen and provides LED lighting. There are also bike spaces and showers.


